Vendors Must Read and Sign This Form at the Bottom.

This signed form must be on file with Larry Baker and L & S Promotions.

1. This is an outdoor event. Tables, chairs, extension cords, booths, canopies, signs, displays or any other equipment will **NOT** be provided by Larry Baker or L & S Promotions.
2. One photograph of your booth set-up must be submitted with your application and fees
3. **Food booths** will be required to have approved fire extinguishers, health permits and insurance. All costs associated with obtaining the above will be the sole responsibility of each respective vendor.
4. Any signs and/or banners must be professionally made as no hand written material will be allowed. E-Z up/Caravan type canopies are required...No flea market type coverings will be accepted.
5. Please understand that Larry Baker and L&S Promotions are solely responsible for the vendor area, and reserve the right for placement of all booths. Those who request a specific booth location must make the request in writing and understand there are no guarantees
6. **Food vendors:** No leftover food, cooking oils or grease will be dumped into trash cans. All booth holders are responsible for cleaning their respective area during and at the close of the event.
7. All items to be sold must be indicated on your application, as there will be **NO DUPLICATIONS** of items.
8. **Food vendors** must provide an additional insured naming: **L&S Promotions, Larry & Sondra Baker, The City of Yuma & The West Wetlands Park** This must be submitted 30 days prior to the festival or no set-up will be allowed.
9. Requests for refunds for booth space fees must be done in writing 30 days before the scheduled event .We understand issues do arise in which we cannot control and we will be sensitive to theses should a refund be requested. Keep in mind there are no guarantees.
10. If you or your company paid and do not show up for the event and **DID NOT NOTIFY** Larry Baker in writing 30 days in advance you may be disapproved for a refund. **NO REFUNDS WILL BE GIVEN WITHOUT 30 DAYS WRITTEN NOTICE. and not guaranteed.**
11. Larry Baker and L&S Promotions reserves the right to have removed from the event, any person, persons or business dispensing food or merchandise that is not of high quality: Anyone violating any law or festival regulation or is conducting themselves in a manner which would be detrimental to the spirit of the show or festival will be asked to leave without a refund. If upon request by Larry Baker to remedy any condition deemed either unhealthy or unacceptable to Larry Baker and/or L & S Promotions and the vendor does not comply, the vendor shall be removed from the show and **NO REFUND** shall be given.
12. In the event the vendor, in any respect violates the terms or intent of this agreement, all payments and fees to Larry Baker or L&S Promotions shall be considered earned and forfeited. L&S Promotion shall have the right to occupy the vacated space.
13. Larry Baker or L & S Promotions is not responsible for loss or damage to personnel or personal property.
